COLLABORATION AGREEMENT

BETWEEN

TATA INSTITUTE OF SOCIAL SCIENCES SCHOOL OF SKILL

EDUCATION

AND

ADARSH FOUNDATION



The articles of this Collaboration Agreement is made and entered into at Mumbai on this the ----- day of --
-----, 2024, by and between,

TATA INSTITUTE OF SOCIAL SCIENCES – SCHOOL OF SKILL EDUCATION, herein referred to as TISS-SSE, a School within TISS, established in 1936, (declared as an Institute deemed to be University under Section 3 of the UGC Act, 1956), and is a grant-in-aid Institute under Ministry of Education, Government of India, having its registered office at V. N. Purav Marg, Deonar, Mumbai 400 088, through its authorized representative **Officiating Registrar**; (which expression shall unless repugnant to the context or meaning thereof mean and include the said Institute and the said School of Skill Education its nominees, successors and permitted substitutes of permitted assigns) of the One Part;

AND

ADARSH FOUNDATION, a trust, having its registered office at A/P Nagzari, Tal. Navapur, Dist. Nandurbar – 425418 & Campus address is at Borvihir, Tal. Navapur, Dist. Nandurbar – 425418 ; (which expression shall, unless repugnant to the subject or context thereof, be deemed to include and mean its nominees, successors and permitted substitutes of permitted assigns) of the Other Part;

TISS-SSE is hereinafter referred to as the “First party” and Adarsh Foundation is referred to as the “Second Party” and both the First and Second Parties are collectively referred to as the “Parties”.

WHEREAS

- A. The Tata Institute of Social Sciences was established in 1936 and was recognized as Deemed to be University under section 3 of the UGC Act in 1956. The Institute is empowered to approve the award of degrees and diplomas based on result of examinations and tests and to confer, grant, award degrees, diplomas, Certificates and other academic titles and distinctions as per provisions of UGC Act and Rules and Regulations framed thereunder. The Institute provides significant space and resources for basic and policy research; and has research collaboration with some of the best universities and institutions across all continents. The School of Skill Education (SSE) was set up in 2011 to impart skill education to Indian youth through appropriately designed Skill education programs. The focus of the School is on developing job-specific skills rather than providing only theory and knowledge-based education. The approach adopted is called the Internship Embedded Skill Training Programme during which many students may also earn a modest financial assistance in select skill knowledge sectors. Hence, the school has decided to obtain certain services from Academic Facilitators who are experts in the Skill Sector.
- B. Adarsh Foundation, an organization is training hub of healthcare courses has expressed its interest to become Academic Facilitator of TISS SSE.
- C. The TISS – SSE considered the interest/proposal of Adarsh Foundation to become Academic Facilitator and after conducting legal due diligence and based on documents supplied by Adarsh Foundation has decided to engage Adarsh Foundation as Academic Facilitator in Healthcare Sector, with a view to offer value education for creating a talent pool of motivated creative and managerial resource for the society.
- D. The relationship between TISS-SSE and Adarsh Foundation to the agreement shall be exclusive, on a principal to principal basis merely for this agreement and shall not be deemed to be a partnership or joint venture or a franchise agreement of any nature whatsoever between the parties, nor shall any relationship of employer and employee be deemed to be created between them. TISS-SSE is agreeable that Adarsh Foundation may collaborate with TISS-SSE in accordance with the National Education Policy for Academic facilitation, Student mobilization, quality of Academic delivery, and such other matters such as admission, collection of fees, examination guidelines etc. as prescribed from time to time. TISS would take the lead and closely monitor the Adarsh Foundation as the academic facilitator. The Parties have thought it expedient to lay down the Terms and Conditions in writing as hereinafter to ensure proper implementation in letter and spirit of the intent of this agreement.
